



## Plagiarism, Collusion and Cheating

### Organisational Area

RTO

### Authorisation

This Procedure was reviewed and adopted by the Park Orchards Community House & Learning Centre Incorporated (POCH&LCI) on 24<sup>th</sup> June 2020.

### Review date

This policy will be reviewed every three years or sooner if required.

### Scope

This policy is for all Students who are enrolled in Vocational Education and Training (VET) at POCH&LCI.

This policy also applies to the Manager, VET Coordinator, Trainers and Assessors and Staff at POCH&LCI who are involved in Vocational Education and Training.

### Objective

This policy aims to define and formalise POCH&LCI's approach to addressing plagiarism and the management of alleged cases. This policy provides a clear definition of plagiarism, collusion and cheating, so that there can be no misunderstanding as to a student's roles and responsibilities with regard to their academic conduct whilst studying at POCH&LCI.

This policy addresses the issue of suspected and/or proven misconduct with respect to the ownership or authorship of intellectual property, or the failure to provide due acknowledgement of the ownership or authorship of the intellectual property of others. This policy is consistent with expectations of ethical conduct.

This policy aims to clearly inform students of their responsibilities so as to prevent instances of cheating and plagiarism from occurring and then to outline the procedure if cheating and/or plagiarism is alleged or proven.

### Policy

POCH&LCI requires that student work submitted for assessment as part of their VET qualification must be their own work. Where work submitted includes material from other sources, the reference to these sources should be made clear.

It is essential that:

- Students do not copy other student's answers in a test or assessment task.
- Students do not allow other students to copy answers in a test or assessment task.
- Students do not inappropriately obtain prior knowledge of an assignment's expected answers/content.
- Quotations from published and unpublished sources are indicated and acknowledged clearly.
- Sources of illustrations, photographs, maps and statistics are clearly acknowledged.



- Web-based materials are not directly downloaded into an assessment and are fully referenced like any other source material.
- Students produce work which is uniquely their own and sign a declaration on their Assessment Cover Sheet (supplied by Trainer).

## Definitions

### Plagiarism

“The practice of taking someone else’s work or ideas and passing them off as one’s own” (Oxford Dictionary)

To take and use another person’s ideas and methods of expressing them and claiming them as one’s own by failing to give proper acknowledgement. This includes published books or periodicals, another student’s work, and information from websites.

**Synonyms:** Piracy, copying, forgery, lifting, appropriation, are all synonyms for plagiarism.

### Cheating

“Act dishonestly or unfairly in order to gain an advantage” (Oxford Dictionary)

### Collusion

Unauthorised or secret collaboration on assessable work with another person or persons with the intention of deceiving others in order to present assessable work as entirely your own.

### Academic Misconduct

Unacceptable behaviour related to plagiarism, collusion or cheating.
