Fees for Pre Accredited Courses

All Pre Accredited Courses that are government funded (through ACFE) are charged at \$1.08 per hour for a tuition fee. Additional charges can include an amenities fee and material costs.

The total fees for a government funded pre accredited course are published in our Term Brochure and available to a student when enrolling in the course.

General

A student with financial difficulties is encouraged to seek special consideration, for a negotiated payment plan, to ensure that the student may access training.

A concession card holder is a student who, prior to the commencement of training, holds a current and valid Commonwealth Health Care Card, Pensioner Concession Card; or a Veteran's Gold Card. The concession provided is also available to a dependant spouse or dependant child of a card holder.

In addition to course costs a student doing an accredited course may be required to pay an additional fee in the following circumstances:

1. If there is a need to be re-assessed for a unit of competency after being offered the opportunities and support available throughout the duration of the course of study. This may include an assignment submitted late, beyond an agreed extension date.
2. If a student is required to undertake a further workplace assessment in addition to those scheduled during the course.

In the event of either of the above events occurring a fee of \$60 per hour for any extra one to one trainer time will be charged.

3. If a student defers or suspends their enrolment (with the RTO's consent) a fee of \$100 may be payable to continue enrolment, and
4. If the fees have increased for the later program, the gap (due to the increased fee) is payable by the student.
